# **Opening of Meeting and Welcome:**

The meeting was held on Zoom. Theresa opened the meeting at 12:30 with the Serenity Prayer. The motion passed with a simple majority and the minutes with corrections were approved.

# **Budget Committee Report - Cherryl C -**

I would like to start this report with a little **background** on the work of the Budget Committee which is a standing committee.

On page 53(57) of the current *Al-Anon/Alateen Service Manual* – "Group funds are used to support Al-Anon's purpose of carrying its message of help and hope to those who still suffer."

In the Ohio *Bylaws* Section C- Financing - "The Budget Committee will determine annually what the total budget will be." At the WSC the budget is constantly reviewed during the year and revised as necessary as has been shared in the quarterly letters from the WSO during the year.

- Our committee consists of 5 members: Cherryl C., Theresa M., Merri G., Ann R, Ginny C., and Barbara W.
- We present to the Assembly a suggested budget at the beginning of each year, based on requests received and approved procedures as found in our Ohio Section D -Budget
- We have committee meetings ahead of each AWCS and Spring/Fall meeting and for any urgent issues.
- We receive requests for funds not covered in the *Ohio Handbook* guidelines—making recommendations for acceptance or rejection based on budget needs of the Area.
- Our *Handbook*, Section XIV-Expenses & Motions gives us specific guidance on the procedures we should use, specific line items/ amounts approved and procedures to use.

The "Spiritual Principles of Al-Anon's Self Support" guide us (see "Financial Matters" in the *Al-Anon/Alateen Service Manual*). Particularly "Tradition Seven which is Gratitude in Action." Other spiritual principles that guide this include:

- Abundance
- Anonymity
- Gratitude
- Responsibility
- Trust
- Unity

Lastly *Warranty 1* which states "that only sufficient operating funds, including an ample reserve, be its prudent financial principle." Page 215(217) "...prudence is a middle ground, a channel between fear on the one hand and recklessness on the other."

This brings me to the Current Update: Our Budget Committee met October 9,2022.

- We had a request to consider a one-time expense for food and hospitality for a group that attended the 2022 KOMIAC held in Indiana. This is not normally done when donating to Alateen transportation to KOMIAC (page 21, Section H.2. After considerable discussion with the current Officers, approved the \$74.20 for a total amount of \$1110.17
- Rose led a discussion on future funding for Alateen. We agreed that a KBDM should be launched so that this can be considered for the 2023 Budget.
- Theresa led a discussion of the current Per Diem allowed expense. We agreed that this should be reviewed and brought to the Assembly with a request for members to look at the Handbook Guidelines and provide feedback to Cherryl C (Budget Chair) or Theresa M (Chairman).
- Lastly, A review of the Budget Line Items definitions will be undertaken by the committee in future meetings.

## Delegate Report - Ann F

Welcome Al-Anon Family,

As your Delegate, I had the privilege of attending a virtual presentation of the Chairman of the Board (COB) letter on August 6, 2022.

The Board of Trustees met in person in July, for the first time since 2020, at the WSO Headquarters, in Virginia Beach. In the future the January Board meeting will be held virtually, as a cost saving measure, to eliminate winter travel, and perhaps fewer travel commitments will attract more Trustees applications.

The Board approved a revised 2022 deficit budget of \$332,730 (which is slightly improved over the \$353,114 prior deficit). This improvement was mainly due to the response from the special appeal letter. Literature sales have not returned to prepandemic levels. Literature prices were increased August 1, 2022. All CAL books will be transitioned to eBooks. This decision was made in insure CAL is available to all members. Both the price increase and eBook decision were made due to increased printing costs, and shortages.

The Strategic Leadership Team (SLT) has recommended postponing or reducing the scope of several current Strategies. Many of the special projects are continuing, such as the new daily reader, Electronic Meeting transformation, 2023 International Convention in Albuquerque, and the 2022 Road Trip!

The Conference Leadership Team (CLT) reported on plans for the 2023 World Service Conference (WSC). This will begin a three year trial of reducing the WSC to four days. It will be held in Virginia Beach from April 20-23, 2023. This decision was made based on feedback from the Delegates, to reduce time away from their personal and professional lives.

This presentation is available for all of you to read on the WSO website, <u>al-anon.org</u>. Look for it under the Members tab, Board of Trustees. I encourage each of you to read the entire report and pass this information along to your groups.

# **KDBM for Electronic Groups Task Force**

Electronic Group Task Force

**CHARGE:** Create a procedure to be presented for approval at the 2022 Fall AWSC, to send to the 2022 Fall OAA, that will be used by any group, including an Electronic AFG, requesting to enter into AFG of Ohio, Area 44.

Recognizing that in accordance with Concept One the ultimate responsibility and authority for Al-Anon services within our Area belongs to its Al-Anon groups, use the KBDM process to create a uniform procedure that will allow an Al-Anon Family Group to join the Ohio Al-Anon Area (44)

This Task Force is now charged with creating a procedure that will be presented to the Ohio Area Assembly for approval. Once a procedure is approved, Ohio Area will be able to list meetings as physical or electronic.

## FRAMING:

Prior to the 2021 World Service Conference, groups, meeting electronically were not part of any service structure. At the 2021 World Service Conference, (WSC), Electronic Meetings were recognized as Al-Anon Family Groups. A motion was passed to remove the Electronic Meetings section, page 88-89 from our Service Manual.

#### **BACKGROUND INFORMATION: What we know:**

# **Historical Perspective:**

**April 2021 World Service Conference (WSC):** The Permanent Electronic Meetings listed on the World Service site (alanon.org) were recognized as Al-Anon Family Groups. A non-paneled Area was formed to include these Groups.

**August 2021 Area World Service Committee (AWSC):** An Electronic Meeting Work Group(EMWG) was formed to study the issue of bringing permanent electronic Al-Anon Family Groups (e-AFGs) into the Ohio Area service structure.

**October 2021 Two Day Fall Assembly:** The Assembly voted to proceed with this issue and a Thought Force was charged with creating a Bylaws Motion that would address allowing electronic AFG's to join the Ohio Area.

**April 2022 World Service Conference (WSC):** The 2021 Non-paneled Electronic Area (Global Electronic Area, GEA) was admitted into the WSC and became Area **98.** The WSO has requested that Areas notify them when they are ready to accept Electronic AFG's into the Area.

**May 2022 Spring AWSC:** A Bylaws motion to expand the definition of an Ohio Al-Anon Family Group was approved and sent to all Groups one month prior to the 2022 Spring Ohio Area Assembly (OAA) for discussion and vote.

## **Existing Motions that pertain to this topic:**

**2022 Spring Ohio Area Assembly (OAA):** The following amended motion was approved by a substantial majority of Group Representatives and group proxies present:

Motion 2022/05 - #1. Revise Ohio Area Bylaws, Article III-Policy, Section A, 5. Territorial Definition, to include: Ohio Area Assembly participation is limited to groups meeting within the boundaries of the State of Ohio, as well as other registered Al-Anon Family Groups that have petitioned by motion, and been accepted to join the Ohio Area.

1. What do we know about our member's or prospective member's wants, needs, and preferences that are relevant to this discussion? What do we wish we knew, but don't?

Concept 4 - Participation is the key to harmony.

The Task Force discussed past procedures for admitting Groups into the Area. It was agreed that the decision was always made at Assembly, with a vote of the groups. The Task Force agreed there is no need for a Group Representative to be present for this vote.

Members want inclusion and ease. The Task Force not want to put restrictions on the Electronic Groups that were additional to what we have for physical groups.

# 2. What do we know about the capacity and strategic position of the organization relative to this issue? What do we wish we knew, but don't?

Our Service Manual, (P24/27, 2022-2025), page 162 says, "Groups or Districts located in one Area contiguous with another Area may, through group conscience and following Area procedures, choose to participate in the second Area and give up participation in the first Area, as agreed upon by both Areas."

# 3. What do we know about the current realities and evolving dynamics that are relevant to this discussion? What do we wish we knew, but don't?

We believe there are Groups in the Ohio Area who have registered with the WSO as Electronic Al-Anon Family Groups who wish to have voice and vote in their local Area Information Service (AIS) and in the Ohio Area Assembly (OAA).

We believe there are Groups meeting temporarily on electronic formats (ZOOM and conference call), that do not intend to return to a physical location.

We do not know what the impact will be of these Groups joining the Ohio Area.

# 4. What are the ethical implications of our choices (pro and cons)? This includes consideration of how the Legacies apply. Identify both pros and cons. What do we wish we knew, but don't?

#### Pros:

Electronic Groups joining the Ohio Area, will extend the hand of Al-Anon to new electronic AFGs and existing electronic AFGs that have not been able to participate in the Area Service structure.

Opening our Area to Electronic AFGs increases the Area's ability to reach people looking for help.

#### Cons:

There may be some confusion regarding supporting our Ohio Area Service Structure.

At the present time the WSO is not able to list in the search function the information for Area Electronic AFGs.

- D. The Group will indicate the District they wish to support, either physical or electronic. The Area Group Records Coordinator will assist in making these changes to the data base, and notifying the appropriate District.

This procedure will be in effect for a one year, trial basis.
